Rules for journalists with accreditation for the La Folle Journée de Varsovie 2022 “Ballads and Romances”

1. **Accreditation is available for professionally active, publishing journalists.**
2. **Accreditation is valid for all concerts except for Smykofonia [Toddler Philharmonic] concerts (nos. 5, 7, 10, 22, 23, 26) and family concerts (nos. 6, 21, 29, 32).** Should you wish to receive accreditation for other events please contact us at pr@sinfoniavarsovia.org no later than 15.09.2022 3:00 p.m.
3. One journalist from a given editorial office may obtain accreditation. Exception is made for the media patrons of the festival.
4. **The number of seats available for individual concerts is limited.**
5. To assure the possibility of attending a given concert, please report to the Press Office to pick up your ticket (tickets will be issued on a first come first serve basis).
6. Each journalist with accreditation is entitled to one ticket to a given concert.
7. Tickets to concerts will be issued:
 - For concerts on 23.09 tickets may be picked up between 6:00 p.m. and 9:00 p.m.
 - For concerts on 24.09 and 25.09 in two sessions:
 - For concerts starting before 3:00 p.m. tickets may be picked up from 10:00 a.m. to 2:25 p.m.
 - For concerts starting at 3:00 p.m. and later tickets may be picked up from 2:00 p.m. until the Press Office closes (24.09 until 8:30 p.m., 25.09 until 7:30 p.m.).
8. Tickets to concerts whose start or end times overlap will be issued to only one of these concerts.
9. If all available tickets for the Media have been issued, attendance at a concert will be possible only if there are available seats left. Persons with badges (including Media) will be admitted after all ticket holders have entered the hall.
10. Journalists with accreditation are obligated to send to the organizers their own materials on the Festival. These shall be sent to the following email address: pr@sinfoniavarsovia.org within 7 days of the date of publication of the materials.
11. The decision to award accreditation will be sent by email on 16.09.2022.
12. Accreditation may be picked up in person only in the Festival Press Office.

The Festival Press Office is located in Teatr Wielki - Polish National Opera and is open:

- 23.09.2022 (Friday) 6:00 p.m. – 9:00 p.m.
- 24.09.2022 (Saturday) 11:00 a.m. – 8:30 p.m.
- 25.09.2022 (Sunday) 11:00 a.m. – 7:30 p.m.

Claiming the accreditation means consenting to the processing of your personal data:

The data controller is Sinfonia Varsovia with its registered office at 272 Grochowska Sreet, 03-849 Warsaw. The administrator has appointed a Data Protection Officer, Anna Walosińska, who can be contacted at: iod.sv@dpag.pl. Your personal data will be processed on the basis of Article 6(1)(f) of

Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 (GDPR) in order to grant you accreditation to take part in an event/concert/festival organized by Sinfonia Varsovia, which constitutes a legitimate interest pursued by the data controller. Your personal data may be transferred to co-organizers of the event/concert/festival or entities providing services to the data controller, e.g. an IT company. The provision of data is voluntary, but necessary to grant accreditation. A refusal to provide data makes it impossible to grant accreditation. Your personal data will be processed for up to 3 months after the end of the event/concert/festival for the participation of which you have been granted accreditation. You have the right to access your personal data, have your data rectified, have your data deleted (right to be forgotten), request the restriction of the processing of your data, object to the processing of your data, and file a complaint with the supervisory authority.
